QST August 2015 (p 75) by Rick Lindquist, WW1ME: **FCC Chairman, Lawmakers Agree to Scale Back Field Office Shutdowns** "In June, leaders of the US House Energy and Commerce Committee reached agreement with FCC Chairman Tom Wheeler to amend the Commission's plans-announced in March- to close a number of FCC field offices. Under the revised plan, the FCC will keep 15 of its 24 field offices open."..."Under the proposals, initiated last fall, the Enforcement Bureau (EB) would have shuttered all but eight sites and cut the number of field agents nearly in half."..."The closure plans were revealed earlier this year via an apparently leaked internal FCC memorandum."

QST August 2015 (p79) by Rick Palm, K1CE there is another interesting article: Interfacing with Local Emergency Officials The article is too extensive to reproduce here but it essentially provides a few tips that may help "get your foot in the door" at local emergency management agencies. It's worth reading.

FCC Eliminating Vanity Call Sign Fee

The FCC is dropping the regulatory fee to apply for an Amateur Radio vanity call sign. The change will not go into effect, however, until required congressional notice has been given. This will take at least 90 days. As the Commission explained in a *Notice of Proposed Rulemaking, Report and Order, and Order* (MD Docket 14-92 and others), released May 21, it's a matter of simple economics.

"The Commission spends more resources on processing the regulatory fees and issuing refunds than the amount of the regulatory fee payment," the FCC said. "As our costs now exceed the regulatory fee, we are eliminating this regulatory fee category." The current vanity call sign regulatory fee is \$21.40, the highest in several years. The FCC reported there were 11,500 "payment units" in FY 2014

and estimated that it would collect nearly \$246,100.

In its 2014 Notice of Proposed Rule Making (NPRM) regarding the assessment and collection of regulatory fees for FY 2014, the FCC had sought comment on eliminating several smaller regulatory fee categories, such as those for vanity call signs and GMRS. It concluded in the subsequent Report and Order (R&O) last summer, however, that it did not have "adequate support to determine whether the cost of recovery and burden on small entities outweighed the collected revenue or whether eliminating the fee would adversely affect the licensing process."

The FCC said it has since had an opportunity to obtain and analyze support concerning the collection of the regulatory fees for Amateur Vanity and GMRS, which the FCC said comprise, on average, more than 20,000 licenses that are newly obtained or renewed, every 10 and 5 years, respectively.

"The Commission often receives multiple applications for the same vanity call sign, but only one applicant can be issued that call sign," the FCC explained. "In such cases, the Commission issues refunds for all the remaining applicants. In addition to staff and computer time to process payments and issue refunds, there is an additional expense to issue checks for the applicants who cannot be refunded electronically."

The Commission said that after it provides the required congressional notification, Amateur Radio vanity program applicants "will no longer be financially burdened with such payments, and the Commission will no longer incur these administrative costs that exceed the fee payments. The revenue that the Commission would otherwise collect from these regulatory fee categories will be proportionally assessed on other wireless fee categories."

The FCC said it would not issue refunds to licensees who paid the regulatory fee prior to its elimination.

As published in the April issue of QST magazine page77: The FCC's "Paperless" License Policy is in Effect The FCC will no longer routinely issue paper license documents to Amateur Radio applicants and licensees. The official Amateur Radio license is the electronic Universal Licensing System (ULS) record. Licensee's will be able to printout an official authorization as well as an unofficial "reference copy" from the ULS License Manager. A new license applicant who has an FCC registration number (FRN) and a valid email address under "Applicant Information" in the ULS will receive an official ULS-generated authorization via email. New applicants lacking an FRN will receive one in the mail as well as a temporary password in order to access the Commission Registration System (CORES). No one will automatically receive a license document.

Thanks to Alton Strong for letting the editor know about the following useful information that was presented in the June issue of QST on page 24 under: Letters from Our Members , Paper Licenses, Continued:

The gist of the letter is that a US Licensee lives outside the US and requires an official paper copy of his license in order to be properly recognized as a US amateur radio operator in other countries. The printed reference copy is inadequate. In response, ARRL VEC Manager, Maria Somma, AB1FM says that there are a number of ways a license holder may obtain an official paper copy and she describes four methods. One that she describes suggests that licensee's may contact FCC support via the web, phone, or mail (I assume USPS) to request paper licenses. In her words "The official license will display the FCC logo and the watermark "Official Copy" will be printed across each page of an official authorization from FCC."

Call to Order:

The "Board" meeting started at about 7:00 PM. Folks used this time to order food, eat, converse and discuss many general items of interest to the club at large. The time was also used to set up audio equipment.

Doug Fitzsimmons, VP, called the general meeting to order at 7:31 pm.

Secretary's Report

Larry, Secretary, asked that the previous meeting minutes be discussed and approved. Some discussion and corrections were made to be published in the revised June Minutes on line. Alton Strong made a motion to accept minutes and Terry Carnahan seconded the motion. The Motion was carried unanimously.

Treasurer's Report: Terry, Treasurer, presented a detailed financial report which included some dues from 2013

Larry Freeman made the motion to accept the report and Fred Maize seconded. The motion was voted upon and carried unanimously.

Repeater Update:

Elmer, KB3WG: Nothing new. There are still some complaints about clipping of voices. Larry pointed out that there is a 1.5 second delay between press of PTT and transmitter being on so that the ID messages can be sent without clipping (most of the time) so we must all learn to delay a couple of seconds after pressing PTT before starting to talk.

Monday Night Net Update:

Dave Steiner: We had 14 check-ins as usual. Also, as usual, we need volunteers for net control.

Monday Night NBEMS Practice Update:

Continues after the Monday night net. Terry also pointed out that there is a demo tonight.

Old Business:

Coverage tests for the Veterans Day parade: ACommittee was set up to apprise the 2m handheld coverage along Philadelphia street in Indiana, PA. Larry Freeman, Dave Steiner, and Al Fister. Larry Freeman agreed to contact members for setting up tests. There was some discussion about the parade details.

There was considerable discussion of dues restructuring ending ultimately with a motion put forth by Alton Strong and seconded by someone: \$35.00-Individual membership with full voting rights, \$50.00-Family membership (Members must live in the same household) no more than two votes per family, \$20.00- Associate membership with no voting rights.

The Eagle Project was discussed: A Weslyan Methodist church near Dixonville has been designated as a disaster center and the leaders would like ICARC to help set up a 2m antenna test to establish that reliable communicate through the 146.91/31 repeater from inside the church can me attained. The project is spearheaded by David Fyock an Eagle Scout and his father. Fred Maize gave a description of the results of a shelter drill from the location several years ago in which it was discovered that the church location was not conducive to mobile communications from within the church through the 91/31 repeater. The folks participating had to drive up a hillside near the church and set up a cross-band repeater operation to effectively complete communications with the 91/31 repeater with handhelds from within the church. ICARC has agreed to test an external antenna setup to help determine what is necessary for successful communication from within the church. We were first contacted in November of 2014 and David was to get in touch with us during the first part of the year 2015 but that got delayed until June 12, 2015. An email was sent to Fred apologizing for the delay and the request for help was renewed. Fred responded that June was a busy month with Airport Awareness and Field Day and that he would forward the email to the club officers and have discussions at the July meeting. Fred is willing to allow us to use his five

element beam for the test. It was decided to proceed with doing a test and helping them decide what they need to effectively communicate from within the church. A committee was set up for the project: Doug Fitzsimmons, Dave Dzelsky, Phil Kopczyk, and Larry Freeman. Doug agreed to be the contact person and gave Fred permission to give them his email and home phone number. He also thanked all who helped with Airport Awareness and Field Day and pointed out that there were two hundred contacts at Airport Awareness, Five hundred and eighty eight contacts at Field Day, forty contacts from the EOC. The logs have been submitted.

Fred let us know that he is giving up the antenna caretaker and organizer job so someone else will need to take it over. Fred was given a hearty thanks and resounding round of applause for all the service to the club over the years. Larry F.was volunteered for the takeover and said he would think about it.

New Business:

Dave Steiner volunteered to check with HOSS' for a "fundraiser" dinner. The discussion focused upon August and September with a final date to be determined. A motion by Phil was made it was seconded by

Fall licensing class was also discussed. Some discussion about details of logistics came up but not discussed. Our main focus is to decide if we want to do it. Dave Dzelsky gave a list of three folks, with their contact information, who have shown interest from Airport Awareness weekend. Ernie Clark also indicated that he would be interested in taking the class. A motion was made by Phil Kopczyk. to have the class, it was seconded by Dave Dzelsky and the motion carried unanimously. Acommittee was setup to work out the details: Doug Fitzsimmons, Phil Kopczyk, and Larry Freeman. Alton Strong emphasized that we need to get the dates setup as soon as possible and communicate the testing date to Bill McMillen as soon as possible so that he can do all the official things that need to be done within 30 days of the exam. We assummed that the EMA center could be used and Terry Carnahan seems to think there won't be a problem but we must firm up that assumption.

Next there was discussion led by Fred Maize concerning the Airport Awarness QSL's. The discussion centered around whether we do them by hand or print up clear lables. He indicate that Craig agreed to cover the cost of the labels which is less than \$20.00. Doug also agreed to cover some of the cost if necessary. There was discussion about the size of the label and 15/16 inch by 2.5 inch labels was decided upon. Doug raised the question as to which would be easier, by hand or by computer printing. Based on previous difficulty and timing of getting people to correctly hand complete the cards, Fred convinced us that the simplest thing is to print labels for every contact from the log and place labels on the cards for those who request a QSL. Fred said that he would cover the cost of the cards. It was decided to use the labels. Doug said that he would take care of printing the labels as soon as he gets the .mdb log file from Larry F. The suggestion was made to put the labels on the cards Tuesday, August 4 before the meeting. Currently, there are approximately forty requests for QSLcards.
