Through the efforts of Ralph, N3LXG, a large lot of computer and related equipment was donated to the Corry and Union City Radio Clubs. After consideration, it was decided that the lot would be auctioned off and the proceeds would be shared equally by the two clubs.

Bill, W7RVY offered to store the goods until the clubs could formulate plans to dispose of them. Largely through the efforts of Dave, WX3E, the Wattsburg Fire Company's Social Hall was secured as a site for the event. On the evening before the activity, a small army of club members met at Bills place to carry the equipment to Wattsburg. Those participating were: Bill, W7RVY; his son; Dave, WX3E; Judy, N3OZH; Lee, WA3HJC; Jerry, W3GHO and his son, Larry; Rob, N3OCL; and Bob, WA3HDK. Once the goods were carried to the Wattsburg Social Hall, we systematically laid out the equipment in preparation for the big day. All of the computer systems were tested and catalogued. The software filled two banquet tables. We were able to leave the building by 10:30.

On Saturday, February 9, the doors opened at 8 a.m. The parking lot was full when I arrived just before ten. There were several hams there who offered good "junque" for sale before the auction started. Most of those consigned some items to the auction.

At ten o'clock auctioneer John Moore began the auction. John is the brother-in-law of Jerry, W3GHO. Much of the success of the auction goes to the skilled auctioning of John. His wife, Teresa and Jerry's wife, Evelyn, served as clerks and did a spectacular job of keeping the fast-moving pace going. Both John and Teresa donated their services at no cost to the clubs.

The auction was over by noon. There was that usual job of policing and cleaning up the area. Thanks to volunteers from both clubs, the clean-up was promptly completed. Each club was able to add \$211 to their respective treasuries. Thanks to all who participated.

MEN FROM MARS FIRST QUARTER 2001

The MARS system has turned the corner and started the New Year 2001 with many reports of challenges met and problems overcome. There has been some reorganization in the paid staff and some of the Department of Defense positions have been turned over to civilian contractors such as area directors and administrators jobs. Otherwise, the nets have been well attended and motivation is at a high level.

The history making number of check-ins for the MARS 75th anniversary net on November 24, with 527 stations joining, is still being talked about. That figure is an all time record that will not be matched any time soon.

Navy MARS station NNN0ESX was official relay station for the Texarkana and Red River County during the January ice storm that left over 100,000 people without electric power, telephones and water. Art worked with the Texas ARES nets on the 75 meter band and relayed the info on the Military frequencies. This was a good example of tri-service working together for the emergency with Navy, Army Mars and the Amateur Service combined to give the needed communications. It would be a good idea to have MARS emergency operations added to the Corry Red Cross disaster plan.

Operation Holiday by all indications was another success, with 541 pieces of traffic passed several (CONTINUED ON PAGE 2

days before the holidays, and the message count from Germany was not complete as of this writing.

Amateurs and MARS members attending the 2001 Dayton Hamvention should note that the combined MARS exhibits will be in booths 356 and 357. There will be a MARS forum held at the convention center this year (instead of at the High School) on Sunday May 20th at 9:30 AM in Room 3.

There are some operators in the MARS ranks that are offered a special role in Communications in a program called SHARES which stands for "Shared resources HF radio program." SHARES is part of the national communication system. All three branches provide members to SHARES. MARS Appointment is based on vacancies, and is available individual MARS members who possess equipment capable of operation on government frequencies. There is usually a long waiting list. SHARES members provide linkage with ARES and RACES in the event of actual emergencies. Other participants are from FEMA, FAA, FBI, DEA and NASA. It appears one would be keeping some pretty impressive company operating in SHARES.

SB QST ARL ARLB007 ARLB007 Amateur Radio Spectrum Protection Act of 2001 Introduced

The Amateur Radio Spectrum Protection Act of 2001 is now officially HR 817. Rep Michael Bilirakis of Florida introduced the bill on March 1 in the US House of Representatives. ARRL President Jim Haynie, W5JBP, and ARRL First Vice President Joel Harrison, W5ZN, visited the Congressman's office to thank him personally for his continuing interest in protecting amateur allocations.

The measure has been referred to the House Committee on Energy and Commerce. The bill seeks to amend the Communications Act of 1934 by requiring the FCC to make no reallocation of primary Amateur and Amateur-Satellite allocations, diminish any secondary Amateur and Amateur-Satellite allocations, or make additional allocations within amateur allocations that would substantially reduce their utility without also providing equivalent replacement spectrum.

Early this month, a contingent of ARRL officials went to Washington for a three-day round of visits with senators and congressmen and their staff members. Haynie and Harrison also visited the FCC, where they spoke with Peter Tenhula, Chief of Staff to FCC Chairman Michael Powell. Haynie was upbeat about the impact of the visits. "Once again we had an opportunity to tell our story about Amateur Radio and the important function it serves, especially in public service and education," he said.

WWV SURVEY PLANNED

The National Institute of Standards and Technology plans to survey users of WWV and WWVH later this year. The time and frequency-standard stations have been airing occasional announcements about the upcoming poll in order to start building a mailing list of survey recipients. The announcements state that "NIST is seeking information on how listeners use the broadcast services offered on the WWV broadcast," but the survey will not begin for at least several weeks.

WWV Station Manager John Lowe says the announcements are being broadcast now as a heads up and to encourage early mailing list signups. The survey itself will not be released until approved by the Office of Management and Budget, Lowe said, and he doesn't expect that to happen until May,

although it could be sooner. The survey period likely would extend through the summer, he said.

According to Lowe, the last WWV-WWVH user survey was done in 1985. "We just don't know who our user base is anymore," he said. Lowe confirmed that the data collected ultimately could be used to determine whether WWV and WWVH remain on the air--especially given the popularity of NIST's other outlets, including its Web-based time server that gets in excess of 3 million hits a day.

"If we get only two people who say they're using WWV, then we've got a problem," he said. Lowe added that he does not think WWV and WWVH will be shut down, and he vowed to "fight for the radio stations," if it came down to that. "But the ultimate decision is not in my hands," he said. "We have to look at our budget and our users."

Lowe strongly encouraged WWV users to get on the mailing list and to send in a survey when the time comes. He suggested, however, that more weight will be given to survey responses from corporate and institutional users of the radio service as opposed to individual users.

To be added to the NIST WWV-WWVH survey mailing list, send your name and postal address to the NIST Radio Station WWV, 2000 E County Road 58, Ft. Collins, CO 80524, or e-mail the information to nist.radio@boulder.nist.gov. Lowe urged WWV-WWVH users to hold their fire until the survey begins.
