Plans are being made to join in the world-wide Scouting celebration of JOTA (Jamboree on the Air) for 2001. This event has been a club activity since Bob Swarm, K3CKO first set up a station in Elgin Park in 1995.

Although we usually set up in Elgin Park, we have also participated in JOTA at Mead Park. This year's activity will be at Elgin Park on October 19 and 20. Several hams have helped with JOTA. # A look at marketing amateur radio.

How did we as a people get stuck in this mentality? Have we been conditioned this way by our educational system? Have we been convinced that "we, ourselves", cannot do things?

I have spent a lot of time over the years trying to sell armature radio to John Q Public. I have operated in public, I have operated the Boy Scout JOTA program, and I have had boy scouts come to my home to see how armature radio works. For the most part, I have failed to generate new ham operators. Why? I have been able to show them the latest and greatest in communication technology. I have always got responses like "Neat!" and "Cool!" But I missed the mark somehow. I think the answer is in the "Watching" syndrome. To the average person under 50 years old my program is just one more adventure program to watch. What I failed to do is convince them that they too could do this. They too, could take part in the high adventure of Ham Radio--Not just watch it.

In September I am going to take part in JOTA again. Boy Scouts love high adventure. This year I will try something new. I will set up a digital station running PSK31 and SSTV at the scout camp. WA3HDK will have the usual Single Sideband station there also. But this year I want to make the theme of the operation: "You too, can do this". Between now and then I will think up every way possible to compete with the "Watching" syndrome. If we can't convince them, we will loose them. Any I ideas you have, I would sure like to hear. There has been a lot of activity in the MARS system since the last Radio Amateurs of Corry Newsletter and I will endeavor to touch on some of it here and catch up on the news. Making interoperatibility happen between the Army, Air Force and Navy MARS has been the goal of much of the efforts

One such activity was a joint open house and air show at Barnes Air National Guard base in Westfield, MA on August 25 and 26 2001. The Canadian Snow Birds performed and Air Force MARS members from Massachusetts hosted a special event station using the call sign AGA1BA on 13.993 Mhz USB Army and Navy Chiefs were asked to have their members join this special event by checking in on both days.

On the same weekend of August 25, 2001 PA Army MARS hosted an interoperatibility meeting for Army, Navy and Air Force MARS members (JFIG) high on top of Tuscarora Mountain in south central PA on US Route 30 just east of McConnellsburg, PA the weather was great and the view from the overlook was breath taking. The all day meeting took place at the Mountain House Restaurant out on the Deck with the view. Several Local MARS members attended and participated in the event: Arnold AAT3JG, Jerry AAR3GF, Dave AAT3EN and Doug AAR3IR Carpooling was the order of the day for the 5-hour drive.

Many of the speakers from Army and Air Force MARS gave insight on the handling of Traffic and Emergency Communications via digital means as well as voice repeaters and High Frequency nets. The support of the National Guard, Red Cross and other services were covered as well as a free Message service for members of the United States Armed forces.

A highlight of the trip was the open house tour of PA MARS site One just across the highway from the Mountain Top Restaurant. This a set of Army Communication trailers with emergency power, many antennas, and lots of equipment ranging from VHF repeaters to HF rigs with the new digital mode PSK31. It was enough to make any red blooded ham and MARS member green with envy. (Army Green, that is.)

## ARRL Petitions for New 60-Meter Amateur Band

ARRL Bulletin 28

A petition filed this week by the ARRL could result in a new high-frequency band for US amateurs. The ARRL has asked the FCC to allocate 5.250 to 5.400 MHz to the Amateur Service on a domestic (US-only), secondary basis.

The League told the FCC that the new band would aid emergency communication activities by filling a "propagation gap" between 80 and 40 meters. "There are times on certain paths when a frequency in the 80-meter band is too low, and a frequency in the 40-meter band is too high for reliable ionospheric propagation," the ARRL said in its petition. The ARRL said the propagation gap can hamper communication between the US and the Caribbean during a hurricane or severe weather emergency.

The ARRL Board of Directors approved the proposal at its July 20-21 meeting. The FCC has not yet invited public comments on the petition. Even if the petition finds favor with the FCC, it's likely to be several years before the new band actually becomes available.

As proposed by the ARRL, amateurs General class and higher would be permitted to operate phone, data, image and RTTY on the new band running maximum authorized power. No mode-specific subbands were proposed.

The ARRL said a new 150-kHz allocation at 5 MHz also could relieve substantial over-crowding that periodically occurs on 80 and 40. If the new band is approved, hams would have to avoid interfering with-and accept interference from--current occupants of the spectrum, as they already do on 30 meters. The band 5.250 to 5.450 MHz now is allocated to Fixed and Mobile services on a co-primary basis in all three ITU regions.

The ARRL's petition cites the success of the League's WA2XSY experimental operation in the 60-meter band, carried out since 1999, which confirmed the communication reliability of 60 meters.

"An amateur allocation in this band would improve the Amateur Service's already exemplary record of providing emergency communications during natural disasters when even modern communications systems typically fail," the ARRL concluded.

## FCC INVITES COMMENTS ON ARRL'S 60-METER PETITION

ARRL Bulletin 33

The FCC has begun accepting comments on the ARRL's petition seeking the allocation of 5.250 to 5.400 MHz to the Amateur Service on a domestic (US-only), secondary basis. The Commission put the proposal on public notice this week and assigned a rulemaking number, RM-10209, to the proceeding.

Interested parties may comment on the proposal via the Internet or e-mail using the FCC's Electronic Comment Filing System (EFCS), information on which can be found at <a href="http://www.fcc.gov/e-file/ecfs.html">http://www.fcc.gov/e-file/ecfs.html</a>. Those commenting should reference "RM-10209" in their postings. Even if the FCC eventually Okays the petition, it's likely to be several years before the new band actually becomes available.

In its petition, the ARRL told the FCC that the new band would aid emergency communication activities by filling a "propagation gap" between 80 and 40 meters, particularly for emergency communications during hurricanes and severe weather emergencies. The ARRL also said a new 150-kHz allocation at 5 MHz also could relieve substantial overcrowding that periodically occurs on 80 and 40.

The ARRL has proposed that General class and higher amateurs be permitted to operate CW, phone, data, image and RTTY on the new band running maximum authorized power. No mode-specific subbands were proposed. If allocated to the Amateur Service on a secondary basis, hams would have to avoid interfering with--and accept interference from-current occupants of the spectrum, as they already do on 30 meters.

The ARRL said that its successful WA2XSY experimental operation between 1999 and this year demonstrates that amateur stations can coexist with current users and that the band is very suitable for US-to-Caribbean paths.

## **Lower Amateur Radio Vanity Fee**

ARRL Bulletin 27

The FCC says the fee for a new or renewed Amateur Radio vanity call sign will drop to \$12 on September 10. Applications received on or after that date will be subject to the new fee. The current vanity call sign fee is \$14.

The FCC proposed the lower fee last March in a Notice of Proposed Rulemaking for the Assessment and Collection of Regulatory Fees for FY 2001. The FCC has estimated that 8000 applicants will apply for vanity call signs in the current fiscal year.

Earlier this year, the FCC also put paper and electronic vanity call sign applications on an equal footing in terms of processing priority. The FCC used to give priority to electronic applications for vanity call signs.

FCC rules stipulate refunds for applicants who inadvertently overpay a regulatory fee. Applicants who determine that they overpaid a vanity fee may request a refund in writing. Requests seeking a "Vanity Fee Overpayment Refund" go to FCC, 1270 Fairfield Rd, Gettysburg PA 17325-7245. Refund requests should indicate the date of application, the total fee paid, and the total refund owed.

## PREZ SEZ...

I have been participating in an 80 meter net Saturday mornings. Here of late the communications have been less reliable, fading in and out and severe interference (QRM). We have switched (QSY) to 40 meters but find the band very crowded. These problems have lead the ARRL to petition to the FCC for a 60 meter band to provide more reliable emergency communications. The request is for an allocation of 5.250 to 5.400 MHz on a secondary basis, meaning the band would be shared with other users. It is proposed that general class or higher would be required to use the band.

There is an extract from a recent ARRL letter about this 60 meter petition: "Interested parties may comment on the proposal via the Internet or e-mail using the FCC's Electronic Comment Filing System (EFCS), information on which can be found at http://www.fcc.gov/e-file/ecfs.html

Those commenting should reference "RM-10209" in their postings. Even if the FCC eventually okays the petition, it's likely to be several years before the new band actually becomes available." I would encourage you in sharing your comments.

It would be great to get another band. A 60 meter band would require changes to equipment and antennas. Change with the right attitude can be exciting. There are many changes--advancements, that have occurred in recent years--Satellite, PSK, computer controlled rigs, DSP and the list goes on. This is a young and advancing field, a great and exciting hobby. Great to be involved in it with you.
