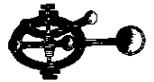

Meet the BARC Members Murray Merner, KF4FQB

I've known Murray Merner, KF4FQB, for many years and he was kind enough to share some of the more memorable events of his life. As a child in Winnipeg, Canada, Murray can remember when he and his friend Ralph experimented with chemistry sets, telephones and made crystal sets. Later he was given a vacuum tube "7 in 1" kit and made a receiver and transmitter. He and Ralph may have committed a Canadian federal law when they participated in a radio roll call of the RCMP!

Murray's serious consideration of Amateur Radio was while living in Toronto. He got a Model 19 Mk III war surplus tank radio and would listen for hours. At that time, he used the telephone line for his antenna and did ok until he found out he should ground the radio and as a result all the telephones stopped working! His mother was not pleased when the telephone man informed her of young Murray's infringement on their wiring. (One regret that he has is that there was a ham across the street that would not give him the time of day.)

Murray's family moved to Chicago. At that time you couldn't get an American Amateur Radio license unless you were a U.S. citizen which took five years residency and a test. Amateur Radio would have to wait. After graduating from high school in Columbus, Ohio he went to a technical school and got an associate degree in

improving and the bands will be getting a lot better. Dxing should be high on your list of priorities. I am not a contester, but! I sure do enjoy logging those "new ones".


We made our first effort at code practice right before the February meeting (1900-1930). Murray Merner, KF4FQB, facilitated the class. Three members attended with the speed

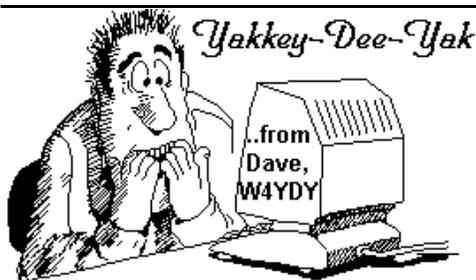

More information has been added to the ARES section on the BARC Internet site. The Monday night net now has the Net Control Station listing for 1998 on the Internet. A link to the page is provided from the ARES section on the BARC home page. It will be updated with new NCS information when it is forwarded to me by **Byron, KA4KGZ**.

Other useful information to club members is on the BARC site. There is an application that can be printed out. It will appear almost exactly like the one that was included with the newsletter a couple of months ago. The December issue of Ham Chatter on the Internet has

information about dues for different classes of members. One of my next projects for the home page will be to get the dues information there. I had an email a couple of weeks ago from someone that wanted that information. By putting it on the home page, it will be easier to find.

Steve Ayer, N2TKX, Editor of the Amateur Radio News Service Bulletin in the March edition asked the question, "Are we on your mailing list?" He was asking the editors of newsletters that are members of the ARNS. He had thirty-five Amateur Radio newsletters listed that he was receiving. There was only one of the thirty-five listed that had Internet and mail editions. That one was the Brightleaf Amateur Radio Club *Ham Chatter*. It looks like BARC is becoming known in many areas now. The BARC guestbook on the web had a couple of nice comments about

BARC from **N4BWO** in Charlotte and **WB4AQK** in Salisbury after they viewed the BARC site.

The Amateur Radio News Service 1997 Publications Contest closed with a total of 71 entries. Lee Knirko, W9MOL, President of ARNS, reported that the judges are hard at work and the results are expected to be announced soon. We hope to get some good ideas on how to make Ham Chatter a better publication.

New ARRL Book--*RF Exposure And You*--Now Available

If you're worried about how to comply with the FCC's new RF exposure requirements, then you'll want a copy of the new ARRL book by ARRL Lab Supervisor Ed Hare, W1RFI. *RF Exposure and You* became available just this week.

As ARRL Executive Vice President Dave Sumner, K1ZZ, put it: "The new RF exposure rules are now a part of the regulatory landscape and are likely to remain so." *RF Exposure and You* is the best way available to ease the transition, Sumner said.

This book communicates one simple message: For the vast majority of Amateur Radio operators, the RF exposure rules are *not* difficult to understand and follow. At 320 pages, *RF Exposure and You* contains all the background information, suggestions and worksheets you'll need to help you comply with the new RF exposure rules and to operate your station legally and safely.

Hare said that preparing the book was "a real challenge and a real collective effort." The result is a book that's probably the first of its kind. "I have never seen this information pulled together in one place before," he said.

ARRL Headquarters staff and volunteers (including the ARRL RF Safety Committee) participated fully with the FCC as the Commission determined the best advice to give amateurs on how to meet the new requirements. The League was able to persuade the FCC to reconsider its rules, and to rewrite them so that amateurs would be less affected. Hare says it took a lot of teamwork between Headquarters staff and outside volunteers to have the book printed and available in just three months.

A. J. Kruger, K7CMM, of Arizona, placed the first advance order for *RF Exposure and You* early this year. This week, Hare personally autographed the first copy out of the box--indicating it was the first copy purchased from ARRL Headquarters. The order went out this week.

Cushcraft Continues in Ham Market; Hires New Veep

Cushcraft says reports of its demise in the ham radio market have been greatly exaggerated. Cushcraft Production Manager Art Hambleton, K1ART, says the New Hampshire antenna manufacturer is still very much a part of the Amateur Radio antenna industry. Rumors that Cushcraft was exiting the ham market apparently mushroomed when word spread of some layoffs at Cushcraft.

Hambleton confirmed that a couple of people had been let go and that Cushcraft had cut back on its advertising in ham radio publications, and he attributed the moves to budgetary cutbacks. But he said "1997 was not a bad year" for the company. And Cushcraft has just hired another ham in a key position.

Hambleton announced this week that Cushcraft has hired Adam Alevy, N1FXT, of Amherst, New Hampshire, as its vice president of engineering. Alevy was previously with Atlantic Microwave of Bolton, Massachusetts. At Atlantic he designed VHF through millimeter wave antennas for communications and tracking applications.

As director of engineering at Cushcraft, Hambleton said, Alevy, 34, will manage the engineering group and design antennas in both commercial and amateur radio markets.

Cushcraft recently announced its X7 and X9 tribanders as part of its "Big Thunder" series. - via *ARRL Letter Online*, 2/13/98

Ronnie Milsap, WB4KCG, is Hamvention Speaker

Country music legend Ronnie Milsap, WB4KCG, will be the 1998 Dayton Hamvention banquet speaker. This year's Hamvention is May 15, 16, and 17, and the banquet will be the evening of May 16. Milsap also will serve as the evening's entertainment.

Blind since birth, Milsap discovered a connection to music while attending the North Carolina State School for the Blind. He learned to play piano, guitar, clarinet, violin and cello, and developed his vocal talents.

Milsap began performing professionally in the 1960s and has won numerous awards, including Country Music Association Entertainer of the Year and Male Vocalist of the Year (1974, 1976 and 1977) and CMA Album of the Year (1976, 1978 and 1986). In 1983, the Academy of Country Music voted Milsap Best Male Vocalist. He won Song of the Year in 1986 for *Lost in the Fifties Tonight*. He also received the only gold Braille album ever awarded. Today,

Milsap can be seen regularly at The Ronnie Milsap Theater in Myrtle Beach, South Carolina.

The Hamvention 1998 banquet will be held at the Nutter Center at Wright State University in Fairborn, Ohio. The Nutter Center has free parking for banquet attendees, no steps, and handicapped access. The banquet also will feature the awards presentation for Amateur of the Year, Technical Excellence, and Special Achievement.

Banquet tickets are \$30 in advance and \$35 (if available) the day of the banquet. Seating is limited. Tickets for the concert only are \$10 in advance, \$15 at the door, and are available by fax, mail, at the Hara Arena box office or at the Nutter Center box office. There's a \$3 charge for concert parking.

Hams Help in Aftermath of Florida Tornadoes

Hams pitched in to help in the aftermath of intense storms and tornadoes in Central Florida that killed more than three dozen and injured hundreds of others. The tornadoes and heavy thunderstorms struck early Monday while most people were asleep, surprising the residents of the affected areas between Daytona Beach and Orlando. Many were left homeless by the storms, now being called the deadliest and most destructive in Florida's recorded history. Weather observers blamed the tornadoes on the El Nino weather system. Some families lost their homes and everything they owned. In one tragic incident, a tornado wrenched an 18-month old toddler out of its father's arms; the child later was found dead. In another miraculous one, the storm picked up a youngster on his

Tower Law Success: Chalk One Up For Amateur Radio

Hams in Mason County, Washington, won't be encumbered by a telecommunications ordinance that would have restricted the height of ham radio towers to 70 feet and imposed other regulations. Andrew Forsberg, WV7M, of Grapeview, reports that several hams in the largely rural Western Washington county (population approximately 30,000) cited federal preemption over local regulation of Amateur Radio activities as well as the hobby's public service dimension to get the County Board of Commissioners to exclude ham radio from the new law last month.

Forsberg says that, as originally drafted, not only would tower heights have been limited to 70 feet, but building-mounted towers could not have been more than 20 feet tall. It also would have held the height of vertical antennas (called "whips" in the proposed regulations) to 15 feet. In addition, the proposed law would have required landscaping to hide a tower and lot setbacks equal to a tower's height--something often impossible on a small, residential lot.

Forsberg said that, at first, the drafters of the new ordinance "seemed to be unmoved by Amateur Radio considerations." In addition to federal preemption, the county hams pointed out the connection between a good antenna system and ham radio's public service contributions--in an area subject to floods, earthquakes, power outages during winter storms, and even volcanic activity). Commissioners "began to soften their position," Forsberg said.

"By the time the vote was taken, the commissioners were well-informed of our position and were commending Amateur Radio for its outstanding contributions to the community," he said. *via ARRL Letter Online, 2/6/98*

electronics about the time transistors were breaking on to the scene - it was there the tank radio was stolen. Shortly after becoming a citizen he was drafted and was in Viet Nam for all of 1969. After discharge, Murray attended Ohio State University where he got his BS in Psychology. For the three months before starting graduate school, he was a prison guard at the Ohio State Penitentiary.

Murray dragged his wife and two kids (ages 2 and 4 at the time) to graduate school at Mississippi State University in Starkville, Mississippi (home of MFJ) a small town in deep rural south. He got his masters in psychology in 1973. He got a job working in a seven county mental health center as coordinator of the day program and did that for eight years while working on his Ph.D. At the time of his graduation in 1981, he also became the executive director of that same mental health center. The center was about to go bankrupt, but with a lot of hard work from everybody, when he left for Greenville, NC in 1986, it was very solvent.

Murray became the Adult Services Coordinator at the mental health center here. He stayed there for 6.5 years before joining the hospital as the director of the Employee Assistance Service.

In November 1995, Murray was talking to **Henry Peszko, WB4DWC**, who told him about an Amateur Radio class being conducted by **Simon**

Jaworski, KQ2V, - he went. He got his Tech in January, '96, his Tech Plus in February '96, and his General in October '96. He's working on his Advanced and has passed the 20 wpm test. It was his honor to be elected First Vice President of BARC for 1998.

With Simon's help he got his Kenwood ST 520 S at the Raleigh hamfest in April '96. The 80 meter dipole was erected with the help of Simon and **John McCoy, K4KBB**. His equipment also includes a MFJ-490 keyer and an AEA keyer. He prefers CW, but contrary to popular belief, he does have a mike.

mattress and placed him gently on an oak tree.

ARRL Northern Florida Section Emergency Coordinator Nils Millergren, WA4NDA, said the tornadoes mostly affected Florida's East Central District, while the West Central District--Sumter County in particular--experienced flooding. At least three Red Cross shelters were reported open in the days right after the storms struck. Millergren says amateurs were providing communications for shelters and had put in hundreds of operator-hours in Sumter County alone. Seminole County ARES/RACES member Allen Wilson, WB7BCI, was among dog-handler hams activated to assist in the search and rescue effort. Other hams were involved in damage assessment and in providing backup communication to relieve

already-congested commercial systems. Net operations on 2 meters continued this week, and volunteers still were being solicited in Northern Florida.

Osceola County EC Christopher Hammock, KE4DUJ, spent several days at the county Emergency Operations Center. Osceola has a small ham population. FCC Computer NETS System Back on Line

The FCC got its errant Amateur Radio licensing computer system back on line February 21 and began processing the backlog of applications. The system went down February 10, and no paper or electronic applications were processed for nearly 11 days as FCC personnel in Gettysburg attempted to troubleshoot the problems with the system.

Gettysburg personnel first processed data submitted on February 11 and 12 by VECs and had an updated file available for the Internet call sign servers on February 21. Since the initial processing went well, VECs then sent on the applications they'd been holding back at the FCC's request. By February 26, it was business as usual. Gettysburg had caught up with the backlog and ran a batch of vanity applications, although a number of applications remained in the work in process (WIPs) stack.

The FCC offered no explanation for the computer breakdown--its longest ever. The situation frustrated those who have been hoping to learn their new call signs or to check on updated licensing status. Call sign servers on the Internet also were affected. The FCC apologized to VECs for the inconvenience. - *via ARRL Letter Online, 2/27/98*
