

Emergency Communications News



Ever seen one of these messages above? If you haven't, then you are likely not alone. Many amateurs are only somewhat aware that our hobby is used to pass messages through the National Traffic System. Any HAM that wishes to dedicate time and skills towards emergency communications should at least be familiar with these messages. They may often be the ONLY means of communicating into or out of a disaster area should the normal means of communications be disrupted.





"Support your local nets and Check in"

The NTS Message is made up of a Preamble, Address, Text, Signature, and a Records and identification block .The preamble contains the information needed to track and handle a message and any reply. The next section contains the name(s) and address of the person to which this message is going and a phone number if applicable. It is then followed by the actual message being sent with one word per block. It is then signed by the individual originating the message. The records section at the bottom is filed out when the message is passed each time. The Middle right identification block is optional.

We will pass these messages on a periodic basis during our Monday night net. If you tune in to the MS Phone Net on 3862 kHz, you may also hear and have the opportunity to pass such traffic.

Give it a try when you can and there is plenty more information out there on the ARRL website under the Public Service Link, National Traffic System.
