Minutes of the July 2004 AARA Board of Directors Meeting

Tuesday, July 13, 2004
Alcatel, PB7 Club room, 3400 West Plano Parkway, Plano TX

OPENING AND ROLL CALL

The meeting was called to order at 536 pm. Present were President Frank Krizan, KR1ZAN, Vice President of Operations Mark Dempsky, N5MD, and Secretary Clarence Sebesta, K5YO. Al Koch was away on business and Miguel Ylagan was unavailable.

SECRETARY'S REPORT

The minutes for the June BoD meeting were distributed by email. There being only a minor grammar correction, Mark MOVED, Clarence SECONDED and the MOTION was PASSED. There were only a couple of newsletters received in the mail.

TREASURER'S REPORT

The treasurer was away on business but submitted his report by email: the current financial statement, list of dues paid members, and the 2004 budget vs. actual expenses. There were no changes to the checking account. Frank noted some discrepancies of the budget's actual expenses vs. checking account that Al needs to check on. The treasurer's report was accepted for audit.

VP OPERATION'S REPORT

Repeater: The repeater has been moved to UTD.

HF Station: Maintenance has the new cable for the Butternut Vertical. Mark is working on setting up a date to install the cable.

VHF / UHF Station: The installation for the VHF / UHF antennas are on hold. Maintenance wants to make sure the HF antenna isn't causing any interference before the VHF / UHF antennas are installed.

Internet: Mark is looking into if a VPN can be setup between the ham clubroom and someone's home network. If this can be done, we might be able to use this to provide an Internet connection for the clubroom.

General: Maintenance is reviewing its lightning protection for PB-7. Mark will try to work with maintenance to make sure are future antenna installation are taken into account.

EXECUTIVE VP'S REPORT (Miguel was unavailable.)

Programs: Frank has found our speaker for July 27th meeting - It's Bill Fell, KK5PB. He will show off his ARES BOOMBOX. This is a grab and go VHF/UHF command post built into an easy transportable field carrying case.

Future programs: September 28 – K5UTD HF Remote Base (K5TCP)

Frank noted that Miguel had sent a memo to the director of personnel to check on the non-processed 2003 check requests.

PRESIDENT'S REPORT

Repeater: Frank reports that the new repeater is working fine with a few minor startup problems. The remote

base is down due to a loose coax connection and a broken coax connector. There is also a software access issue to be resolved. Mark Butler is working on the problem. The repeater is operating at 90 watts output at the diplexer. The level may be reduced to improve de-sense. Mark Dempsy suggested a way to check for internal diplexer heating.

OLD BUSINESS

2004 Operating Budget: The special meeting for June 15th that was called at last month's meeting was not held. There was a problem with the Alcatel reflectors that prevented the required 72-hour advance notice to the members. Therefore, Frank **MOVED:** To recommend the revised budget as prepared at the June 8th 2004 board of directors meeting be presented to the AARA membership at the July 27th general monthly meeting. Mark **SECONDED** and the motion was **APPROVED**.

Missing Laptop: No information on if we have tag information. According to Clarence, no computer equipment was included on the insurance list. How the laptop was acquired appears unknown.

Unescorted Access: Frank is checking into the status of the approvals. Once members, who have submitted requests, have been approved, they will be notified by email.

The meeting was held in the AARA Club Room at Alcatel, PB7. In attendance were: Mark Dempsy, N5MD, VP-Operations, Al Koch, KB5VSL, Treasurer, Miguel Ylagan, KC5FEJ, Executive VP, and Frank Krizan, KR1ZAN, President.

Frank called the meeting to order at 5:32 p.m. He mentioned Clarence, K5YO's surgery to explain his absence. Frank opted to be the Recording Secretary for the meeting.

REPORTS

Secretary

In the absence of the Secretary, Al **MOVED** to accept the Minutes of the May 11, 2004 AARA Board of Director's Meeting as published in the April/May, 2004 Newsletter. Miguel **Seconded**. Motion **PASSED**.

Frank reported that no other significant communications were received during the past month.

Treasurer

Al reported that there had been no transactions since the May 25, 2004 General Membership Meeting. The balance remains at \$2,961.61. There being no corrections, the Treasurer's Reports were submitted for audit.

Al reported we still have not heard anything about the 2003 Company Reimbursements. Miguel offered to contact Christina Custer, who works with Scott Seale, regarding the status of the reimbursements.

Vice-President, Operations

Repeater – The repeater is being prepared for its move to UTD.

The Board agreed that a Budget should be drafted that did not consider the 2003 Reimbursement shortfall and that when (and if) the 2003 reimbursements are received another revised budget could be prepared. Changes were made to the 2004 Budget, originally approved at the Jan. 27, 2004 GMM. [Ed. - See secretary for official minutes for non-published financial figures.]

Frank MOVED to recommend the Revised Budget at a Special Meeting of the AARA Membership to be held June 15, 2004. Mark Seconded. Motion PASSED.

The Clubroom's missing laptop was discussed. No one seems to know its whereabouts.

Al to check with Clarence to determine if the laptop in the clubroom was listed on the ARRL Insurance and what is its ID and serial number.

Miguel is to pursue identification of the laptop from the docking station asset tag.

There being no further business, Al MOVED, Mark Seconded and Motion PASSED to adjourn at 6:58 p.m.

Minutes of the May 2004 AARA General Membership Meeting

Tuesday, May 25, 2004

OPENING AND ROLL CALL

President Frank Krizan KR1ZAN called the meeting to order at 1732 CDST. Other officers attending the meeting were Executive Vice President Miguel Ylagan KC5FVJ, Treasurer Al Koch KB5VSL, and Secretary Clarence Sebesta K5YO. Also attending were George Huling K5GH, Bill Hammon KA5SOT, Kris Mraz N5KM, Thorsten Prutz K5TCP, Keith Parris WB5RBA, Charles Penry YI9VHU/WA5VHU, Cindy Penry KD5CCB, Dhawal Moghe.

SECRETARY'S REPORT

The minutes for the April GMM were published in the newsletter. There being no corrections, Frank declared that the minutes were APPROVED.

TREASURER'S REPORT

Treasurer Al Koch submitted the current financial statement, dues paid list and current operating budget vs actuals. The May phone bill payment expenses were shown on the latest transactions report. One new member application was received.

Frank noted that the revised 2004 operating budget was to be presented at this meeting. However, Alcatel has still not addressed reimbursement for 2003 funding. That number affects what projects would be budgeted. Primarily it is hoped to include a satellite antenna system. When Alcatel gives the club a response, a special meeting may be required to approve

the 2004 operating budget later this month.

The financial report was submitted for audit.

VP OPERATION'S REPORT

Acting-VP Operations Mark Dempsy was not present. Frank noted that the VHF antenna has been relocated but Facilities has not furnished the cable yet.

Frank reported that the new repeater is FINISHED. It is hoped that the move to UTD will be made early June. The Linux software was also finished which will improve remote control access.

The club station was photographed by CQ magazine and will appear in a forthcoming issue.

EXECUTIVE VP'S REPORT

Programs: The May meeting will be a joint dinner meeting with other Telecom Corridor clubs at 6 pm, May 22nd at Ryan's Family Steakhouse Restaurant near Jupiter and Buckingham.

Miguel noted that he would ask if one of the computers might be outside the firewall. Visitor Thorsten Prutz suggested what we might be able to make a wireless connection to UTD or other external source.

Training: Miguel hopes to organize a class for this fall.

PRESIDENT'S REPORT

As mentioned earlier, it is hoped that the June board meeting will be able to work out the final details of the revised 2004 operating budget.

Frank announced that the club plans to hold field day using the clubroom station. A show of hands indicated at least 7 of those present would participate.

NEW BUSINESS

Frank noted that we've been unable to locate the club's laptop computer. It hasn't been seen since the move. Anyone knowing the whereabouts of the laptop please contact Frank or one of the officers.

Thorsten Prutz K5TCP made a brief presentation about requesting permission to allow UTD to connect to Echolink via the Alcatel repeater W5VV. He has been helping UTD and David Brandenburg with the K5UTD station. They are interested in making an Internet remote base for UTD students. This would also tie into hf stations that David set up at various local schools.

Thorsten also offered AARA the use of his hf mini beam, an hf vertical antenna and a vhf/uhf vertical if the club was interested.
