## Minutes of the August 2004 AARA General Membership Meeting

Tuesday, August 24, 2004 MCI Campbell Creek Building, 2400 North Glenville Drive, Richardson, TX

#### OPENING AND ROLL CALL

Executive Vice President Miguel Ylagan, KC5FEJ, called the meeting to order at 1740 CDST. Other officers attending the meeting were, Vice President Operations Mark Dempsky, N5MD, Treasurer Al Koch, KB5VSL, and Secretary Clarence Sebesta, K5YO. Also attending members were George Huling, K5GH, Ernie Brouwer, KD5MFE, and Keith Parris, WB5RBA.

#### SECRETARY'S REPORT

The minutes for the July GMM were passed out to the attendees for review. There being no corrections, Al MOVED the minutes be approved and Mark SECONDED. The minutes were APPROVED.

There was no correspondence other than newsletters.

## TREASURER'S REPORT

Treasurer Al Koch submitted the current financial statement. The 2003 company reimbursement was deposited and transferred to the savings account. Financial report was submitted for audit.

#### VP OPERATION'S REPORT

Repeater: The new repeater has been moved to UTD. Parts from the remote base were used so the main repeater could be put on the air. The remote

base will be fixed when the replacement parts are available.

HF Station: The cable *for* the Butternut Vertical is now in the clubroom by the HF station. The cable does need to be shortened. Some receiver testing has been done with the antenna; however, no transmissions have been made with the antenna. Tests need to be done to make sure the antenna is properly tuned. Low power interference tests need to be done before high power is applied to the antenna.

VHF / UHF Station: The installation *for* the VHF / UHF antennas are on hold. Maintenance wants to make sure the HF antenna isn't causing any interference before the VHF / UHF antennas are installed.

Internet: IS has assign two of our PCs a static IP address. These IP addresses are allowed to go out through A1catel's firewall to the Internet but not to anywhere within the firewall. Miguel Ylagan is working to setup accounts on these computers so are members can use them to access the Internet.

General: Maintenance is reviewing its lightning protection for PB-7. Mark will try to work with maintenance to make sure are future antenna installation are taken into account.

### OPENING AND ROLL CALL

## SECRETARY'S REPORT

The minutes for the July BoD meeting were distributed by email. There being no corrections, the minutes were APPROVED. There was nothing received in the mail.

#### TREASURER'S REPORT

Al submitted the transactions report that includes the 2003 check reimbursement. It was agreed that the check could be placed in the savings account for use at later time. #### OPENING AND ROLL CALL

## SECRETARY'S REPORT
