7) Committee Reports

a) Technical Committee - Kevin WJ8G

Kevin WJ8G commented on the work-through of the back-log of items. With the progress that is being made, we should be caught up soon with both coordination requests and updated surveys. I have helped Frank N3FB write up some correspondence that accompanies initial coordinations, and helped him with some coordination tasks within our region, as well as fielded information from/to coordination bodies that surround us. I helped with two coordination disputes and helped write the resolutions for each of them. I have also been pre-screening the coordination applications for glaring inaccuracies, and where necessary contacted the prospective trustee by phone to obtain correct data. This will help streamline the coordination process and help eliminate erroneous data. I have been working behind the scenes updating several web pages to make them easier to read and understand.

b) By Laws Committee – Jeff N8PSU

Jeff N8PSU comments via electronic submission: I apologize for my absence at today's WPRC, Inc. meeting Now that much of the dust has settled and the board and members have had the opportunity to refine the new electronic communications systems is working well, I feel much more comfortable that we all have a solid vision as to where the WPRC is going forward. Additionally, the technical committee and frequency coordinator are obviously working more efficiently than ever before thanks to the efforts of Frank, Kevin and the other committee members.

I have also completed a task of restructuring another non profit agency's bylaws which was the focus of many meetings that took me away from WPRC work earlier this quarter. I think that those distractions are over and I can now begin to finally focus on the WPRC.

To date, we have gathered examples from a variety of non profit organizations and have reviewed them to some degree. We have discussed membership language changes that will offer more clarity surrounding who can vote on issues. We have also looked at conflicting language in the existing document and that is a solid focus when we develop the draft documents.

As we create the revised by-laws document, we hope to provide a solid revised WPRC structure, and also empower the organization and board to establish "policy" outside the bylaws that would reflect how business is conducted on a day to day basis. Policy is more easily updated and revised and that would eliminate the need to modify the bylaws to change certain policy (ie how mail is logged, sent etc)

I hope to have a conference call with our committee in the coming weeks if we can align everyone's schedule. I want to thank Carmine, Alan, Elaine, Kevin and the BOD for offering input as we develop this document. Also, I think it is worthy to mention and congratulate the Board and the organization on the accomplishments and transparency associated with the WPRC communications both internally and externally - We are a more customer friendly and accessible WPRC today because of a solid effort with a great vision!!

Though I had hoped to offer you a document today, I was unable to meet that goal for a variety of reasons. Stay tuned for the July meeting.

c) Public Relations Committee – Jim N5NWC and Scott N3XCC

Jim N5NWC mentioned that all of his communications since the last meeting have been on e-mail and with favorable results.

Scott N3XCC comments via electronic submission: I feel that we need a new user friendly website and an easier way to maintain it more efficiently. Public relations would also be GREATLY enhanced by having a new and understandable set of bylaws. When someone has a problem with the way something was done, there can be an intelligent response complete with a quoted section of bylaws or publicly published policy to back it up.

Elaine K3EMM announced that the new WPRC, Inc. membership certificates are completed and may be picked up today by anyone in attendance. Remaining certificates will be mailed out. Thank you Elaine for your work on this very important project intended to recognize our membership.

8) Old Business

a) Updates on coordination surveys returned (or not) since last meeting.

Frank N3FB reported: I have completed a full audit and comparison between the paper database and the working database. I now have the forms doing the math to show feet and convert to meters. I have added a few tables to better track changes. Now there is a table that will retain all of the log numbers and brief notes as to what they were about. It is coming along, still needs more work.

I made routines to pull data and send to Google earth to help with determining distance between sites. I also have a routine that will pull data for the web site posting and a routine to pull machines that have not responded to the survey. I have 47 machines and links on that list.

Since our last meeting in January, I have sent 7 requests to surrounding coordination bodies for approval. I have approved 8 requests from the surrounding areas. I have issued 14 final coordinations. With Kevin's WJ8G help we have a cover letter that is being sent with the initial coordination forms explaining the next steps in the process. I have approved 7 initial coordinations.

I have gone from a backlog of about 12 months to a backlog of about 4 months. As I continue to refine the process of working with the database the wait time will improve.

At the last meeting, we circulated a list of machines that indicated that they were not on the air and not going to be on the air. All items not responded to are slated to be placed back into the pool June 20, 2103 as decided in our January meeting. Refer back to the meeting notes as seen at wprcinfo.org

b) Coordination Disputes 147.315 N3QC and 147.210 W3MIE

After careful discussion among the Council and James K3TLP it was stated that there is no dispute and James requested that the Council consider Log #3490 and #3491 resolved.

c) <u>wprc.us</u> status to transfer as agreed by KR3P at November Special meeting.

Kevin WJ8G gave the group in attendance a history lesson on this issue where a Joe KR3P was to release wprc.us back to the WPRC, Inc with full assistance of members willing to help Joe make the transfer. It was noted that the WPRC, Inc. has, to date, paid the fees related to this domain. It was on record and agreed to by Joe in previous meetings that he would complete this final transfer of our property back to the WPRC, Inc. as this was the final open issue between the Council and Joe.

Tom K3WS offered to the members in attendance two options to resolve this issue. 1. We simply ignore Joe's unfavorable actions. 2. Someone in attendance motion to terminate his membership for lack of compliance to his documented agreement with this council leaving him "Not in Good Standing".

There was a lot of around the room discussion and quite a few questions.

Cynthia WB3CNJ stood up and addressed the entire group with a long list of negative personal opinions on Joe's past actions. When done, Tom K3WS thanked Cynthia for her comments but made it clear to the group that her comments we her own personal opinions. The Councils business with Joe is clearly documented.

Sam W3CYO motioned we ignore Joe and move on with important business and let Joe KR3P someday do what is right.

Tom Brew K3WS made a motion to authorize and task the Technical Committee (lead by Kevin WJ8G) with the duty of evaluating and researching the best option to totally optimize the operations of the WPRC, Inc from membership application – frequency coordination application, information access and status update look up by all parties with official business with the WPRC, Inc. Noting most other Frequency Coordination Groups offer a very automated and informative database system. Our members deserve simplicity while the board and committee members deserve the same simplicity in carrying out their duties. In short we need to securely automate and bring our processing into the 21st century as also noted by Sam W3CYO. Kevin and his team are to present us the best option to accomplish this effort.

A budget will be proposed and decided on by the board. Including web site hosting, design, and updating.
