- 4: Frequency Coordinator report: Frank N3FB stated that he is in the process of rebuilding the data base as 2012 frequency coordination surveys are being returned. Frank further suggested he would send a second notice to those who have not responded, sometime in August, with a new deadline date.

6: Cynthia, WB3CNJ asked about her application for the West county ARA membership. It was stated that new applications received today are to be acted on at the next meeting. She also discussed the status of KF8FY, Rick Robishaw's repeater, in Springboro. She stated it was not on the air, or even located where it is coordinated. WPRC board will review and report back. Freq Coord N3FB noted he did receive a freq coord survey response from Rick KF8YF and that his repeater was on the air.

7: Bill, N3BPB discussed the current status of the WPRC Incorporation. The secretary reported that it was noted in meeting minutes from past years that WPRC paid an attorney to do this for us. But through research, Bill N3BPB had discovered that WPRC was not incorporated by the PA Department of State, at this time. Bill stated that he has been in contact with the law firm of Reed/Smith who can handle this action for us for fees for incorporation fee, and registration. Bill stated that no legal fee would be charged as that would be done pro-bono. Bill stated that at this time, with the approval of the BOD, the name "Western Pennsylvania Repeater Council" has been reserved, at the PA Department of State, for a period of 90 days with an expiration in early November.

Joe, W3BC motioned, with second from Lee N3NWL, that we table all incorporation documents until all members have an opportunity to review. Motion was withdrawn upon further discussion.

Carmine K3CWP motioned, with second from W3ON, to proceed with only the name registration, with no by law changes. Motion carried.

8: At this time, discussion moved to Joe KR3P, and his request as to why the WPRC had sent him several registered letters asking for the return of WPRC materials. Discussion ensued between Joe KR3P, several BOD members, and members of the audience. On a question about the propagation software by Paul W3PLP, Joe KR3P stated he does not have the propagation software, as the disc that was returned to him was defective.

Discussion continued about the frequency coordination data that Joe KR3P has in his possession. Joe KR3P stated that all data on the WPRC BOD Yahoo Group website, files section, was current to 2010. Paul W3PLP noted that there is no information there. Joe KR3P then offered the WPRC BOD, what is supposed to be three sets of back up data files in sealed envelopes. Joe KR3P requested one set be kept by a third party, one by the WPRC BOD and the Frequency Coordinator, and one set that he would retain for his own use for legal reasons not disclosed. Chairman Heck, KE3EI, responded that this would not be acceptable, as all data in Joe KR3P's possession belongs to the WPRC. Chairman Heck further informed Joe that under our Constitution that he is to return all materials in his possession, including files (both paper and electronic), and office supplies, as they do not belong to him.

Further discussion between Joe, KR3P, and others, produced no consensus, with Joe KR3P insisting that is the only way that he would turn over materials in his possession. Then a motion was made by Paul W3PLP, second by Paul AB3PJ, to hire a lwayer to try and obtain the materials, on behalf of the membership as is required by the WPRC Constitution.. Motion did not carry on voice vote.

Cynthia, WB3CNJ, stated her belief, as a paralegal, that we as a board should accept the package.

Joe, KR3P, mentioned that he cannot supply out of area coordination information, because it is protected data, and is owned by those councils.

Discussion on the WPRC BOD and WPRC Members Yahoo Group web sites, that the WPRC had paid for the registration some years ago, but is under the control of Joe KR3P. Joe KR3P was asked, that all information on any of these Yahoo Groups be removed as the WPRC no longer uses those Yahoo Groups.

9: Nittany Area ARC rep asked which address they should send their frequency coordination survey responses too. The secretary noted that all mail to the WPRC should go to the WPRC mail box address in Wexford PA. The secretary then explained that he records all mail received, where he logs it in, and then forwards the documents to the appropriate board members. NARC rep also noted they are not using the area standard tone for their repeaters. Their rep was asked to submit the changes to the WPRC so that records can be updated, using the appropriate form. The frequency coordinator mentioned that all changes need to be submitted by late November, so that correct information can be sent to the ARRL for publication in next year's ARRL Repeater Directory.

10: Motion by Sam, W3CYO, second by K3YV, Ellwood, to adjourn. Motion carried.
