6) Correspondence report.

Tom – K3WS mentioned that we had received and logged a few items. Most of the items received were all resolved or replied to between meetings and nothing is requiring any further action in this meeting. One item, Log number 3553 July 19th 2013 from WW3S, makes clear the request of the Crawford Amateur Radio Society in which they state that Cynthia Rushton WB3CNJ is NOT authorized to speak on their behalf. Tom also noted that there are currently 47 log items of new business in various stages of completion since the last meeting.

7) Committee Reports

a) Technical Committee – Kevin WJ8G

Kevin WJ8G commented on the work-through of the back-log of items which still continues, but we are nearly up to date - working in near real time. The quickest turnaround time to be expected is 60 days, and we are currently close to that timeframe depending on how many other Councils' involvement are required. I helped Frank with two coordination disputes, two reports of interference, and their resolved. I am continuing to pre-screen the coordination applications for inaccuracies, and where necessary, contact the prospective trustee by phone or email to obtain correct data. I have been working on updating several web pages to make them easier to read and understand.

Another order of business covered by Kevin was to request the Chairman to consider appointing Tom 'Sparky' Orzetti WB3IGM to replace Joe McElhaney KR3P on the Technical Committee. Paul Plants W3PLP approved the action. This action did not require a vote however there were no noted objections from the room.

b) By Laws Committee – Jeff N8PSU

The By Laws Committee met from 12:15 to 1:15 prior to the regular meeting. This meeting was to predominately discuss language and conflicting language surrounding membership classifications and voting privileges. Attendance included Jeff Blake, committee chairman, Alan Carnes committee member, Paul Plants W3PLP, Jim Knox N5NWC, Chuck Gessner W3ON, Tom Brew K3WS, Kevin Custer WJ8G, Elaine Bailey K3EMM, Terry Carlson W3GFD, Frank Bobro N3FB.

In my report to the membership I acknowledged that we also received some correspondence from Cynthia Rushton who e-mailed some suggestions for content change (Log number 3554) that will be reviewed and acted upon as applicable through regular process. The meeting today allowed me to obtain feedback and ideas from the board and some general members.

Our primary goals continue to be to streamline language, eliminate contradictory language and provide the WPRC, Inc. with a more functional document, and to allow for the development of a business and

operational policy document to accompany the by-laws. Much of the impeded progress this year is a combination of my inability to effectively schedule a committee meeting over late spring and summer.

c) Public Relations Committee – Jim N5NWC and Scott N3XCC

Jim N5NWC mentioned that all of his communications since the last meeting have been on e-mail and with favorable results. Jim also mentioned he has received a few very positive comments about the opening prayer before the meeting.

Scott N3XCC, commented for those repeater owners who can't seem to get their machines back to operational status on their own, the WPRC may be able to help.

8) Old Business

a) Updates on coordination surveys returned (or not) since last meeting.

Frank N3FB reported:

Since the last meeting in April, we have sent out 6 Final Coordinations, 7 Initial Coordinations and have 2 applications pending approval from surrounding coordinating bodies. 5 applications were sent back for various problems. There were 9 requests from surrounding bodies that were approved. We had one complaint of interference from Western NY. That has been resolved. I am continuing to do substantial work on the database. I have made an entry that will track changes and access official log numbers. I believe that I have it worked out on how to export the data suitable for posting on the web. With the changes I have made to the database, I am finding it easier to work with and keep track of what I am changing. I hope that this will allow me to speed up my approval process as I am still running much slower than I would like.

c) Paper Repeaters:

Introduced as an idea for the board to consider by Elaine K3EMM, is the matter of "Paper Repeaters". This may be considered a touchy subject by those holding on to a frequency coordination just to have one, but to the individual or organization wishing to truly host and operate a machine it is a great nuisance.

After a lot of around the room discussion and a history lesson on the subject by W3ON, this is now a subject of action for the WPRC, Inc. and the technical committee. Soon there will be procedural changes proposed which will help define the handling of this haunting issue. We do welcome your suggestions now and will consider all options. Many of you may even know how others handle this issue. We simply want to see everyone interested in actually going through the cost and responsibility of hosting a machine, allowed the chance to do so. Please send us your comments. sec@wprcinfo.org

Scott N3XCC added: For those repeater owners who can't seem to get their machines back to operational status on their own, the WPRC, Inc. may be able to help. Our technical committee can help with advice on most repeater hardware. There are LOTS of talented folks within the WPRC, Inc. membership. As such, we may be able to help you get in touch with other folks in your area that can lend you a hand if needed.

Our goal as a council is not to de-coordinate machines, but rather to assist those with machines that are off-the-air, get them back on-the-air as best we can. Paper repeaters are of no help in emergency situations.

d) Elections:

e) John Salsgiver – KB3SVJ Representing the Fort Armstrong Wireless Association Armstrong County, informed the Council that the K3QY two meter repeater had been moved from it's site near Ford City, Pa. to a site further north. He asked what the status was concerning the coordination or the new site, to which he was told that the paper work was forwarded to other repeater coordinating bodies to determine if there were any issues by other repeater owners with an output frequency of 145.410 MHz. John was reminded that the coordination process for the repeater move is treated like a new coordination process; he understood and assured that his questions were answered. John mentioned that he was green regarding repeater upkeep and operation.
