# ZL1BMP Silent Key

Captain Lindsay Alexander MacMillan (2<sup>nd</sup> Jan. 1921 – 2<sup>nd</sup> Jan. 2010) preferred to be called "Mac". He went to school in Wellington and began his sea-going career as a cadet with Shaw Savill, ultimately gaining his Extra-Masters qualification in England. (He recalled hearing traffic in England from Musick Point when the station first opened in 1938.)

With a leaning towards teaching, he came ashore, his career changing to marine education, culminating in his becoming a well-known and greatly respected Director of Nautical Schools in Wellington and then Auckland.

His interest in radio communications continued on his retirement and he gained his Amateur Radio callsign, ZL1BMP, in 1979. He joined Auckland Branch (02) at that time, his membership continuing for the rest of his life. Familiar with the use of Morse code through his marine career, CW became his preferred operating medium. He had an excellent, readily distinguished "fist", heard in regular "skeds" for the next 25 years, concluding when his move to a retirement facility precluded the establishment of an Amateur Radio station. He continued, however, to enjoy listening to CW on the Amateur bands, although he could no longer transmit.

He is well remembered as an active and loyal member of the Auckland Branch of NZART.

#### General Business

#### 1. Committee Vacancies

There are three vacancies. Selwyn Ross, ZL1BRC, and Steve Miller, ZL1FS have agreed to stand. The Committee discussed the manner of filling these vacancies:

- 1. Making appointments (as suggested by members at the 2009 AGM though not formally resolved).
- 2. Calling a Special General Meeting and holding an election (as stipulated by the Constitution).

Resolved to call SGM for 20 February 2010; ZL1AAR / ZL1WAL

#### 2. Jock White Memorial Field Day:

- Branch participation will be held in the grounds of the Clubroom on 27th and 28th February 2010.
- A new rule allows for 40m and 80m phone operation for clubs with limited manpower, wherein there
  are pitfalls of making two entries.
- Gwynne urged that field preparation one week before the event is essential, else there is insufficient time to erect antennae on the Saturday morning.
- Selwyn advocated that coverage of NZ was more important than DX. He offered the use of his 4:1 balun for a 142 feet length horizontal (elevated on the north side) square loop antenna for 40 metres.
- Discussion about how best to manage this event was deferred until Members meet on Saturday 20th
   February 2010 when an appointment will be made and operators (particularly CW operators) recruited.

#### 3. Internal Maintenance:

- The window is repainted and is ready to be fitted. Steve (who returns of 8 February 2010) will be asked to employ his builder friend. A coordinated move of the computer equipment in its vicinity need to be made first. Mark to be advised.
- · George offered to provide Mark with a suitable smoke detector if given its specification by him.
- Reblocking the entrance of the Clubroom is necessary. Wallace reported that his QTH was reblocked by a handyman using a car jack and some wedges. Gwynne expressed concern about the safety of people doing this.
- $\cdot$  When repainting, Gwynne requests that the base of the building should not be brown; rather, grey.

#### 3. Telephone line:

• George reported that he has spoken with Leith. He said that he will assume coordination with Chorus to find and fix the break in the telephone line between the roadside and the clubrooms; and with Scarbros'.foreman (who has agreed to dig a trench).

#### 4. AREC:

- Japie was advised to liaise with Donald Webster for guidance about AREC matters.
- It was suggested that they meet with Civil Defense Officers and Auckland City Transition Committee to remind them of our presence and readiness (even if we have to operate from our individual QTHs).

#### 5. Tenure:

- Wallace is to follow up with Gerard Kilpatrick about research on this matter before approaching Brain Scarborough again. There is an opinion that the lease should make mention of our presence on the and. Other correspondence with Civil Defence (a responsibility of ACC) is supportive. And a visit by ACC's Property Manager is indicative of their interest in the Clubroom.
- George said that we should apply for a grant from ACC for discretionary spending on its maintenance.

#### 6. Antenna:

- The repair of the 80 metre antenna has been ongoing for some months now. Steve is to be asked to attend to this.
- Selwyn reported that he has plans for a 10m antenna, that is also overdue some attention.

### The Wanderer's Return!

Yes it was Tuesday 2<sup>nd</sup> Feb. that I got back. My position on board was Electrician/3<sup>rd</sup> Engineer.

### **Brief** outline of the trip:

We went from Amsterdam to a large bay in southern UK "Margate" (for shelter).

Then we had a plan change and went to Le Havre France.

After a couple of weeks we went to Keil Germany, Via the Keil cannel which we entered from the Elbe river. This was only a short stopover where we picked up Campaigners & Activists!

We went out into the Baltic Sea where we had to intercept a ship carrying nuclear parts for a "EPR" (European Pressurised Reactor) new build that was under action in Finland.

We slowed down about 5 miles from the outher ship and dispatched the activists by fast RIB boats to do a protest action on this ship which was the "Happy Ranger". (54Deg. 23'N by 11Deg.48'E.).

After this we carried onto Helsinki Finland. It was a relatively short stopover of about 24 Hours.

Out into the Baltic again, and made our way to Stockholm Sweden.

Thursday 26<sup>th</sup> Nov. I had had a guts full of things breaking down, and needing repair so I contacted the GPI office and RESIGNED!

However as they couldn't replace me at short notice, I got talked into staying on for a while...Back to Amsterdam!

About three days later we set off again, this time to Copenhagen. We were to be here for quite a long time, for the duration of the "world climate conference". During this time we were turned into a floating hotel for what seamed like 100's of different GP personal. (It was a trying time for the crew).

Just a few days before we left winter set in... Snowing and COLD! We were due to depart on Sat. 19<sup>th</sup> Dec. but on the 18<sup>th</sup> most of our crew were missing, as they had gone to a protest action, and didn't come back. The next morning we found out that GP had approx 49 people arrested, and 33 in jail! Most of these people go released the next day. In due course we were off again. Oh rough sea again, rolling our way down the Baltic!

Monday 21st. I was supposed to be on E/R watch, but I spent most of the day in my bunk and the C/E did the day watch for me. (Spoilt again!) It was about 2000 hrs that we got to the first lock again. This is the canal between Denmark & Germany.

Then onto the Netherlands.

Xmas back in the ship yard was very quiet as most of the crew had gone home for a few days. Guess who was stuck on the ship and had to do several days of watches... Yes! My replacement was due, but had some health issues with his ticker! He arrived a few days later.

BUT after I had given him the handover notes and shown him around, this next morning he supposedly got an email from his doctor with a problem with his blood count so off he went back to Germany! I got asked if I would stay on for the trip to the Canary Islands, where they were taking the ship for dry docking .SO I said Ok!

Sat 16<sup>th</sup> Jan. We departed for Las Palmas, Gan Canaria Is.. Oh a trip across the Bay of Biscay at this time of year was NOT a good idea! Jan 26<sup>th</sup> we arrived!

MORE R & M!, Oh by the way, my replacement turned up. (Same man again!).

GPI arranged a flight home! via everywhere they could I think of.

30th Jan 0430 Hrs. my departure, Taxi to the local airport.

Flight home was Las Palmas to Madrid; Madrid across the Atlantic to Chicago. I pulled a new trick here and did the "distressed passenger" act, and got a 24 hour stopover. (I had to pay for the night in a Best Western, but that I didn't mind.) The next day to Los Angeles and on to Auckland.

I intend to write up the trip in detail from my notes and diary.
